Ontario Medical First Response Competition

Job Description (Judges)

The Ontario Medical First Response Competition will be **Saturday, May 11, 2024 at Fire and Emergency Services Training Institute (FESTI)**– 2025 Courtney Drive East, Mississauga, ON L5T 1J3.

As a Judge at this event, you will be asked to be on-site for 8:00am through 6:00pm. Meals and refreshments will be provided for you throughout the day. Light refreshments at a reception following the last scenario and cleanup will be provided to all helping us out on the day.

Our Chief Judge for this event will be Daniel Levinter. Chief Personnel Coordinator for this event will be Anthony Chui and he can be reached by email at personnel@omfrc.ca.

Please wear clothing that is comfortable, appropriate to the weather, and appropriate for the function(s) that you have volunteered for. Remember, most of your day will be spent standing so good footwear would be beneficial. During the competition, when you are functioning as a judge, it is important that you are NOT wearing your St. John Ambulance uniform (if you have one).

On the morning of the event, you will be briefed on your specific responsibilities by the Chief Judge. You will be working as part of a team that will include a Casualty Simulator, patient(s), and logistics person. Throughout the day, should you have any questions or concerns, the Chief Judge will be available to assist you.

As a Judge, you must agree to keep all first aid competition scenario materials and documentation confidential; before, during, and following the event. It is also essential that you are able to identify situations (real or perceived) that could be deemed as a *conflict of interest*. Such situations may arise prior to the event or on the event day and must be reported immediately to the Chief Judge for resolution.

Marking Guides will be based on the principles of first aid and not, necessarily, on specific treatments. It is expected, therefore, that you have the requisite knowledge of first aid theory and skills, as well as experience, to fairly and impartially judge competitors on the care that they provide. The official reference for the Junior, Intermediate, and Senior categories will be all material found in the St. John Ambulance - *The Complete Guide to First Aid and CPR – First on the Scene* text. The official reference for the Advanced category will be all material found in the St. John Ambulance – *The Complete Guide to First Aid and CPR – First on the Scene* text and the St. John Ambulance - *Medical First Responder Student Manual*.

I thank you for your time and support of this important event. Your efforts will help in the training of our medical first responders from across Ontario and in so doing help save lives and reduce the pain and suffering of those injured in accidents.
